# Introduction

#### **Letter from the Executive Director**

This Annual Report for fiscal year 2022 will cover what happened in a year that was truly unpredictable at the close of the previous fiscal year. Fiscal year 2021 (July 2020 to June 2021) was remarkable for CentrePointe Counseling, in that it was the first full fiscal year impacted by COVID-19, as well as by elevated social disagreement and divisiveness on political issues on a national level. Those resulted in a huge increase in demand for mental health therapy. Video-based counseling allowed our counselors to see more clients than they ever had previously. But experiencing a remarkable year meant uncertainty on what would follow.

In fiscal year 2022, our counselors saw more clients than during the years preceding fiscal year 2021. The demand for counseling to address anxiety grew, as well as requests for child and youth therapy. Nevertheless, client activity did not reach the same level as it did in 2021. Operationally, we underwent changes that impacted the entire organization. Internal and administrative support, patient billing and more were improved for better counselor and patient experiences – a necessary investment.

Throughout the year, our counselors' sense of community grew. CentrePointe's values center on a Christian faith, a faith that is integrated in our counselors' work and regularly processed amongst staff on a professional level. It is a meaningful experience to witness counselors' involvement in their mutual edification.

I hope you will pray with us, and consider supporting our work and growth, as we continue our mission to serve our neighbors.

### CentrePointe is...



#### **Built for the Utmost**

CentrePointe Counseling's hiring process is very selective: we look for proven skills and knowledge, an active Christian faith and administrative integrity. Counselors are supported by supervisors and colleagues who advise, equip and encourage them towards developing their counseling work and skills. Our administrative staff is committed to working reliably and proactively, and to act above board in all our practices. This year our board subjected itself to a self-review in an effort to assess its own performance and abilities. While time consuming, quality and integrity are the core from which we do the work we intend.

From July 2021 to June 2022 (FY22), demand remained high for mental health therapy, following an extraordinary increase in demand the previous year (mainly due to anxiety over the COVID-19 pandemic, social distancing and its impact on relationships). This year, stress and anxiety once again were the top conditions of clients seeking therapy. Our counselors hear the needs of clients, and have helped more clients than they have before. Because of this, a knowledgeable, supportive counselor community rooted in faith, timely and relevant Continuing Education subjects, and the practice of self-care have been more important than ever for counselors to serve clients well. It is our continued work and hope to provide the conditions for that level of support to our counselors, and to see its impact on clients.

# On Mission

#### **Investing in Hope**

CentrePointe Counseling is centered on the good news of salvation and restoration by Jesus Christ. What does that mean for a counseling organization?



When CentrePointe Counseling formally began in 1983, its mission was to provide counseling to ministers and ministry leaders, so that healthy church leaders could lead congregations in a healthy way. Today our mission has broadened, so that counseling with informed, professional Christian counselors could be financially and geographically accessible to anyone in Maryland, but especially those referred to us by church leaders.

As a staff, we grapple with topics that affect counselors and clients on a philosophical and theological level, and that impact the psychological and clinical. These are not quick or easy conversations; they cover topics such as how faith impacts mental health, the roots of faithfulness or disbelief, and viewpoints on processing present-day social and cultural concerns. For example, what happens to an individual when the church he or she attends becomes fractured? How do they experience the disruption of what was once a peaceful, family-like community? We ask why clients ask the many questions they have on faith and counseling, and what is happening in their inner world that informs their outer choices.

Spending dedicated time discussing and processing these types of questions are important to informing and equipping counselors, but it also indicates the importance of the spiritual lives of counselors. Clients are served better – whether or not they ask to incorporate their faith in their counseling sessions – when counselors approach them with wisdom and knowledge.

#### **Mercy Activities**

As a product of our mission to provide accessibility to high quality care with Christian counselors, this year we witnessed a huge increase in the number of clients referred to us by their health insurance companies. Across all counselors, waitlists became the norm. Clients have also been continuing sessions for longer periods of time, just as they had in the previous year. This made it difficult for anyone to see our counselors, including those who sought financial assistance through our Samaritan Fund.

Despite this, through the generosity of our donors, we helped clients requiring financial assistance to access 200 hours of counseling. In the coming years, difficulty in accessing our counselors will continue, unless we add substantially to our counselor numbers, which is our goal. The need is clear. We desire to help more individuals with




financial need to access our counselors, and welcome referrals from church leaders aware of the help we can give.

As a 501(c)3 non-profit charity, we are able to fundraise for our Samaritan Fund, which is fully supported through donations alone. We seek to use these funds to reach church communities with limited budgets through counselor lectures and workshops. We truly appreciate the prayers of our supporters.

# Client Trends


CentrePointe counselors saw 956 clients in Fiscal Year 2022 (July 2021 to June 2022) – roughly the same amount as the previous fiscal year. Stress-induced conditions, anxiety and depression once again comprised the majority of conditions. The most significant change was the increase in PTSD/Traumarelated conditions, which grew compared to the previous year. This growth may to some extent be attributed to the long-term effects of community loss.

#### **Client Conditions (Primary)**




This year, for the first time in four years, referrals from health insurance companies matched the number of referrals from friends and family. Insurance companies have been proactively referring clients to us, even becoming competitive with each other. This may explain the increase in the proportion of clients with no faith/agnostic beliefs compared with last year, as clients became more diverse.


#### **Referral Source**



#### **Clients by Faith Background**




#### **Client Payment Method**



Despite the increase of client referrals from health insurance companies, the proportion of clients using health insurance as a payment method remained about the same as last year. There was a relatively small proportional reduction of clients using Samaritan Fund and sliding scale grants.

As with last year, telehealth (video-based) counseling was far more popular than in-person sessions. It is no surprise to see clients' counties of residence shift around proportionally compared with last year, indicating the ease of geographic accessibility.



# Financial Update

During Fiscal Year 2022, video-based counseling continued to allow counselors to see relatively high numbers of clients. Less down time, access to clients in larger geographic areas, comfort amongst clients to see counselors by video, and heavy referral rates from insurance companies facilitated relatively large and steady caseloads, even for new counselors. Combined with increases in health insurance reimbursement rates, counseling revenue remained relatively high, especially considering we had a smaller number of counselors this year. Expenses rose modestly compared with the previous year.

CentrePointe Counseling's counselors are able to schedule hours at their convenience, while also employed as staff members. Until this fiscal year, counselors had a low minimum requirement of billable hours that contributed to unpredictable and sometimes insufficient levels of revenue generation. This fiscal year, new counselors worked a higher number of hours, and this contributed to a rise in revenues per counselor.

Net Assets at the year-end were healthy and at a high level compared with previous years. We are thankful for this outcome from an unpredictable year. Fiscal Year 2022 (July 2021 - June 2022)
